European Health Alliance e.V. Membership Fee Regulations

§ 1 Membership Fee Obligation

The Membership Fee Regulations govern the membership fee obligations of the members of the European Health Alliance e.V. in accordance with § 4 of the Association's Articles of Association adopted at the founding meeting on December 4, 2023. They stipulate an admission fee and an annual membership fee. The Membership Fee Regulations may be amended by the General Meeting with a two-thirds majority.

§ 2 Contribution Amount, Form of Payment, Association Account

- (1) The annual membership fee is for
- a) legal entities under private law with the intention of making a profit: €20,000
- b) micro-enterprises and small and medium-sized enterprises pursuant to Article 2 of the EU Commission Recommendation 2003/361/EC, graduated according to the number of employees, turnover, and balance sheet total:
- o b1) Micro-enterprises with fewer than 10 employees and less than €2 million in annual turnover and balance sheet total: €1,000
- o b2) Small enterprises with fewer than 50 employees and less than €10 million in annual turnover and balance sheet total: €2,000
- o b3) Medium-sized enterprises with fewer than 250 employees and less than €50 million in annual turnover and €43 million in balance sheet total: €5,000
- c) corporations under public law (universities), non-profit organizations, and other non-profit organizations staggered according to number of employees, turnover and balance sheet total:
- o c1) Smaller organizations fewer than 250 employees and annual revenue of less than €25 million €2,000
- o c2) Larger organizations with 250 or more employees, or annual revenue of €25 million or more: €10,000

- (2) In cases of doubt, the Executive Board decides which category a prospective member falls into according to paragraph 1.
- (3) In justified individual cases, the Executive Board may recommend a reduced membership fee for a prospective member to the General Meeting, which will decide on the recommendation.
- (4) Membership fees are to be paid by direct debit or bank transfer.
- (5) The association's account is held at Deutsche Apotheker- und Ärztebank eG under

- (6) The Board of Directors is authorized and obligated to open an association account with Deutsche Apotheker- und Ärztebank eG and to communicate the account details to the members.
- (7) For members joining during the year, the membership fee is calculated pro rata according to the calendar month of joining (1/12 of the annual fee for each month of membership or part thereof). For members leaving during the year, the full annual fee is due.

§ 3 Payment Date

The payment date is February 1 of the respective calendar year.

§ 4 Admission Fee

(1) Each member pays a one-time admission fee equal to 25 percent of the annual membership fee stipulated in § 2 (1).

(2) The membership fee is due within six weeks of the decision on admission, and for founding members within six weeks of the notification of the association's bank account. Section 2, Paragraphs 3 and 4 apply accordingly.

Section 5 Data Processing

Contributions are collected electronically. The necessary member data (names and bank accountdetails) are stored in accordance with the GDPR.

Section 6 Termination of Membership

The obligation to pay contributions ends with the termination of membership in accordance with Section 3 of the association's statutes.

Section 7 Entry into Force

This membership fee regulation will be communicated to the members by means of a copy of the minutes and will enter into force on December 4, 2023.
